Please take care to leave your area free of litter or any debris from your product. **Full season Vendors will have a designated/permanent spot.** Everything you sell does not have to be homegrown or handmade by you!

**BAKERS & CANNERS EGG & FOOD SELLERS:** The Cottage Food Operation Act requires anyone wishing to sell foods made in their home kitchen to register with the Macoupin County Health Department before selling products to the public at a Farmers' Market.
