We are excited to announce we are bringing back the Farmers' & Artisans' Market for the 2020 season! Our Market will be held in the Pavilions and Parking lot at the Schneider Park every Thursday 4p.m. – 7:00p.m. from May 7th - Oct 8th, 2020.

Registration fee is \$5.00 for a single week, or If you'd like to commit to a whole season, the discounted price is \$25.00 for all 22 weeks. You can mail your whole season registration to the Village of Brighton PO Box 458 Brighton, IL 62012 or drop it off at 206 S. Main St. Brighton (Village Hall). Do not mail if you are paying weekly, as you will still have to fill out registration each week. You can pay at Village Hall the day of Event Prior to Set Up Time. *Set Up Time is at 3:00p.m. – NO PAYMENT WILL BE COLLECTED ON SITE. FEE'S MUST BE PAID PRIOR TO SET UP. You must show your Season Placard on your table or Weekly Receipt must be visible each week.

Vendors are responsible for bringing any of the following items (if desired): tables, chairs, E-Z Up tent or umbrella, signage, bags or other suitable packaging, scales, and display material. Please take care to leave your area free of litter or any debris from your product.

BAKERS & CANNERS: The Cottage Food Operation Act requires anyone wishing to sell foods made in their home kitchen to register with the Macoupin County Health Department before selling products to the public at a Farmers' Market. EGG PRODUCERS: The State egg inspector has advised that we keep a copy of everyone's egg license on file, so please include a copy with your registration form.
