# November 4, 1996 Brighton, Illinois

The Village Board of Trustees met on November 4, 1996 at 7:00 p.m. for the monthly meeting. Meeting was called to order by Mayor George R. Miller.

Minutes of the October 7th regular meeting, October 15th Ordinance Committee meeting and October 24th Special Meeting were reviewed. Motion was made by Cunningham, seconded by Farmer to accept the minutes as presented. Voice vote carried unanimously.

Motion was made by Oertel, seconded by Farmer to accept the treasurers report. Voice vote carried unanimously.

<u>Visitors</u> - John Moore said he had attended the zoning meeting and a permit was turned down for an auto repair and salvage yard on Dutch Lane and he wondered why it was turned down and the Village is allowing one in the city limits. He felt that there were inconsistencies in granting permits and this should be corrected. He stated that Grover Towell had at least 10 cars sitting around his place and he felt at least 4 cars were inoperable. No inoperable cars can be on property without a special use permit. Attorney Watson said the property was zoned agriculture and John should bring the inoperable cars to the attention of the police department. Board members agreed that this ordinance needs to have much needed consideration in the re-writing.

Larry Kemper was present on the re-financing of the existing bond debt. Attorney for his company has found some technical legal problems. At this time it is not known exactly what affect the Macoupin Tax Cap (if passed in the election) will have on the re-financing of any bonds. He asked the board to have a meeting for further discussion

of this. Four items that need to be done:

- 1) Description of projects being considered.
- 2) Registered voters in Village.
- 3) Money needed to be spent on new projects.
- 4) Post notice for meeting.

Mr. Kemper told the members that the city is under no obligation to sell bonds.

Attorney Watson told the members that if there is a tax cap passed this would be in affect Jan. 1, 1997.

# **Committee Reports**

Public Works report was given by Oertel.

Farmer requested to discuss Wayne Cox subdivision (Lakeview Dr.) at the continued meeting on Wed. Nov. 13th.

Jeff Kruse requested the \$600.00 from Thomas Woody sewer tap-on be given to him since Kruse made the sewer available. Farmer stated the reason he was against this at the committee meeting was if the tap-on is given to Kruse then the tap-on should be given to Bill Watts for the residence built outside Country-Air subdivision. (Watts has never paid the Village for the tap-on). Kruse told the members the board had asked him to put the sewer at the back of his property so the Woody's could tap-on. (As of this meeting the clerk had not got to research the minutes. Since the meeting in the July 1995 minutes it a motion was made for Kruse to put the sewer at the rear of his property.)

Motion was made by Oertel, seconded by Down due to the prior agreement for Kruse to build the sewer lines at the back of the property to give the Woody sewer tap-on fee of \$600.00 to Kruse on this one piece of property only. Roll call vote carried unanimously.

Cunningham stated that there is no ordinance on capping off sewer lines when a house is torn down. Dan to talk to Gary on tapping this off. This to be considered when ordinances are reviewed.

Dan has received a proposal of \$7,900.00 for the drainage on Ransom Street from Widman Construction. This to be done before winter. Motion was made by Farmer, seconded by Oertel to accept this proposal. Roll call vote carried unanimously.

Jeff Pruett has received his Class 3 sewer classification. Ordinance does not provide bonus for this, only Class 2 and 4. Dan thought the compensation was the same amount for both. Motion was made by Farmer, seconded by Cunningham to pay Jeff the bonus for completing his certification. Roll call vote carried unanimously.

Some members had viewed the video tape of the sewer lines in the southwest section of town. The line under the railroad track at Hwy 67-111 to South Street has a bad section of pipe. Blockage also at Market and Jersey Street. Farmer requested a feasibility study be done to replace the 8 inch pipe where it joins the 15 inch pipe in the field east of South Street, under the railroad and highway to Jersey and Market Street. Dan to try to have prices by the meeting on Nov. 13th.

Motion was made by Farmer, seconded by Oertel to place the report on file. Voice vote carried unanimously.

Zoning report was read by the clerk.

Public hearing held on Oct. 22, 1996 to discuss requests from Glenna White and Jeffrey Kruse for special use permits.

Glenna White, 212 Charles Street, requesting to replace an existing mobile home with a new one. No objections. Permit approved.

Jeff Kruse, 501 Market Street, requesting the property to zoned to R-3 multiple family dwelling. Letter read from Thomas Woody objecting to this. Apartments would not be low income. Robert Vonnahmen was concerned about property values. Kruse thought the property was zoned commercial since it belonged to the railroad.

Board members wanted to find out the classification before taking action. Voting would be delayed until property

classification was found out.

Regular meeting was held on Oct. 29, 1996.

Special use permit was discussed for Jeff Kruse. Kent Scheffel said the village attorney stated the property at 501 N. Market Street is currently zoned R-1 based on Article 4, Section 3 of the zoning ordinance.

Visitors were given the opportunity to ask questions and state objections. Motion was made and seconded to approve the special use permit applied for by Jeff Kruse. Roll call vote. Motion failed.

Building permits approved:

Gary Werts - Maple Street - car wash addition. Marvin Mouser - RR 1 Box 32A (Bunker Hill Rd.) - storage shed. William Preis - 43 Country Lake Subdivision - house.

John Moore stated nine cars in need of repair parked at Grover Towell's business near Moore's home. Moore questioned the inconsistency of a permit denied for Ron Hargrave for a garage and salvage yard and why one is permitted within the city limits. It was suggested that Moore bring the complaint to the Village Board.

Sandy Brown, RR2 Oakrest Rd., stating a mobile home had been moved in and asked if a permit had been issued. No permit issued from Brighton. Clerk to check and see is Jersey County issued a permit.

Schoeberle questioned the replacing of the mobile home at 212 Charles Street. He felt that the board was not allowing anymore mobile homes to be moved within the city limits. Normally if the owner of the property lives in the mobile home it has been replaced. Schoeberle felt this report should be tabled at this time.

Motion was made by Isringhausen, seconded by Farmer to place the report on file. Roll call vote.

Jeff Kruse told the board members that if the people are going to govern what is built in town, how do they expect the town to grow.

Ordinances revisions have been handed out to the committee and approved.

Request \$2,500.00 (Capital Expense) for computer program be released for the purchase of this. Motion was made by Isringhausen, seconded by Down to purchase the computer program. Roll call vote carried unanimously.

Motion was made by Oertel, seconded by Farmer to place the report on file. Voice vote carried unanimously.
