Brighton, Ill. December 6, 1976

The regular meeting of the Village Board of Brighton was called to order by the president of the board, Walter Ahlemeyer, at 7 p.m. in the Brighton municipal building on December 6. Clerk called roll of trustees.

Present: Little, Birk, Carr, Wild Absent: Wooldridge, Markwardt.

Minutes of regular meeting of Nov. 1 and special meeting of Nov. 8 were reviewed. Little made motion to accept. Carr seconded. Voice vote, carried unanimously.

Treasurer's Report given by Luriel Bott as follows:

Visitors who request to be heard: Glenn Strohbeck was in and inquired about the zoning ordinance, and also explained to board how other cities handle zoning. Alton has a rate of \$40.00 plus \$10.00 for plumbing, \$10.00 electric and \$10.00 for sewer; Madison Co. \$75.00 for 12,000 sq.ft.; Bethalto, \$25.00; E. Alton, \$5.00 and Jerseyville \$40.00. Ours is \$2.00 per M. Strobbeck asked that the board look the ordinance over and try to charge a flat fee, also he could not understand why a builder had to submit plans drawn to scale. Gary Miller felt that there would be no problem if we changed to a flat rate. Birk made motion that we keep drawings to scale for commercial buildings, eliminate drawing plans for homes and make charges up to \$2,000 free, \$5.00 for a building \$2,000 to \$5,000, and \$40.00 for buildings \$5,000 and over. Wild seconded. Roll call vote, carried unanimously.. Birk made motion to suspend rules so this can take effect immediately. Carr seconded. Roll call vote, carried unanim-

Gary Miller said that the McElroy property is not zoned for trailers and he has been informed as to rules for trailer courts.

Street & Alley Report. In absence of George Farmer, clerk read this report. Farmer has done the usual street work, burned leaves, cleaned culverts, set out trees, and worked for Water Dept. four days. He asked for permission to purchase a battery for the big truck. Carr mentioned that the old truck is in very bad condition and Walter said serious consideration should be given to purchase of a new truck in next years appropriations. Birk suggested getting our name on a list for a government truck. Ahlemeyer appointed committee of Little, Carr and Birk to check into The board approved Farmer this and come to some conclusions. permission to purchase battery, points and plugs and anything else that is needed to keep truck running. Little made motion to accept report, Wild seconded. Voice vote, carried unanimously.

It was reported that water has been standing in front of McElroy's store.

Letter from Bill Cole, Greenfield Argus stating that Southwestern Journal is under new ownership; letter from Mr. Maslauski, engineer, bringing his price on engineering pool from Letter from IC-Gulf RR regarding survey \$18,000 to \$12,000. of land that village would like to buy. Clerk to contact Ralph Narup for plats which Abraham had when city hall was built. Letter from Jay Sitzes resigning from Zoning Board and from Richard Woods resigning from police force. made motion to accept these resignations, Carr seconded. Voice vote, carried unanimously. Clerk to write them a letter Letter from Todd Sanitation raising their price from \$12.00 to \$16.00 per month. Clerk to check with Cunningham of Community Sanitation and if his cost is less, to cancel with Todd as of January 1, 1977 and place business with Com-Letter from Lawrence Albert asking village to amend liquor ordinance that major share-holder of tavern can live outside city. Atty. Watson said a corporation can be owner of a tavern but major shareholder has to meet all requirements of individual owner and an individual owner has to live in city To do otherwise, the ordinance would have to be changed. Mayor Ahlemeyer felt that since others had had to move into town, he felt that there should be no exceptions and the present ordinance should be lived up to. Clerk to write Albert accordingly. MFT tax for October, \$1077.67; Municipal tax for August, \$3540.46.

Ordinances: Ahlemeyer explained about amending ordinance on zoning, that a resolution had just been passed to
amend. Atty. Watson stated that a resolution will not do it,
as it would have to be published in book form. He was instructed to write up ordinance which must be published within
ten days of passage.

Scheffel asked for authority to pay Clark Painting \$14,670.00 retaining \$1630.00 of the \$16,300.00; Fred Benz, \$12,220.19 less 10% or \$1,222.92, this bill being for east line which is complete except for tests. Birk made motion to authorize payment of these two bills. Carr seconded. Roll call vote, carried unanimously. Scheffel said water hauling will start again tomorrow and until get to 20' in tank - if below that, will have to stop hauling again.

Scheffel asked for a decision on roof of shed as it is leaking badly. Birk mentioned that the roofing should be a matched job. Atty. Watson felt that we would probably not get title to rail—road land before February, and suggested that we accept low bid on roof in two phases; put roof on first building and the balance subject to getting acquisition of land. Carr made motion to authorize committee to get building specifications worked out which would include roof to tie in; with under—standing that as soon as we get title to land, we would complete the rest of the building. Little seconded. Roll call vote, carried unanimously.

Scheffel is to report back in January on Phase II, after checking with Sheppard. Until the state pays us, we cannot pay. Little made motion to accept Water Board report. Carr seconded. Voice vote, carried unanimously.

Wild seconded. Roll call vote, carried unanimously. Atty. Watson stated that he recently had a chance to see how our police conducted themselves in serious situations and he would like to commend them on their good behavior and efficiency in handling affairs. Ahlemeyer also said he had received a letter from one of the judges in the county seat indicating that our police handle things in a professional manner, and that they know the procedure. Little made motion to go on record commending Police Department, Carr seconded. Voice vote, carried unanim-Clerk to write Broyles and Rubemeyer to this effect. ously. Ahlemeyer submitted names of Chas. Porter and Lynn Harrelson to serve on Police Committee to fill resignations of two committeemen. Little made motion to this effect, Wild seconded. Voice vote, carried unanimously.

Zoning Inspector's Report: Ron Baron was absent. Gary Miller said there were two men on Zoning Committee whose terms expired this month - Bob Handling and Roger Watts. Ahlemeyer asked Miller to get a definite answer from these men as to whether or not they are interested in serving another term - if not, he should be thinking of someone to fill their places.

Joe Dearing said application for grant for 10" water line has been sent in.

Ahlemeyer explained swimming pool, and stated that he would never ask the tax payers to pay for a pool. Clerk read Resolution regarding pool. Carr made motion to pass, Wild seconded. Roll call vote, carried unanimously. Little made motion to go ahead with contract that was sent out by Maslauski, engineer, on engineering up to a point on swimming pool for cost of \$12,000. Wild seconded. Roll call vote, carried unanimously. Clerk to send Maslauski \$500.00 with contract.

Birk made motion, Little seconded, that the Mondays after Christmas and New Years day be vacation days for office voice vote, carried unanimously.

The Lewis & Clark Library system is supplying books to Brighton Library free of charge this year, but after this, if it is decided to continue their service, there will be a \$300.00 yearly charge. The library has asked if the city can provide this \$300 and the village has consented to this as long as Revenue Sharing money is available.

Clerk was instructed to send ambulance service a bill for \$442.70 for their insurance premium which started Sept. 15, 1976. She is also instructed to try to get a breakdown on various items for different departments, such as Fire Department, Workmen's Comp., also contents of ambulance.

The Street lights are not in yet, but have been promised for this week.

Birk made motion to recess until 8:30 p.m. Wednesday, Dec. 8. Recessed 10:50 p.m.

Continuation of regular meeting of December 6.

Ahlemeyer stated that at our regular meeting on Dec. 6, adjusting zoning ordinance was discussed. After Atty. Watson checked ordinance, he decided we cannot amend this without a hearing. This hearing has to be set up by Zoning Board of Appeals and published in paper. After that, Zoning Board makes decision as to what to do, and maked recommendations to town board, who makes ordinance and amends it.

Carr made motion, Wild seconded, that the clerk of the Village Board be directed to inform the Zoning Board of Appeals that the Village Board, pursuant to Article 25, Section 1 of Ordinance #354 has moved for an amendment to Zoning Ordinance #354 and that the clerk request the Zoning Board of Appeals to publish notice of, and conduct a public hearing on said motion pursuant to Article 25 of said Ordinance. Roll call vote, carried unanimously. This to be published in next weeks paper.

## RESOLUTION

WHEREAS, the Brighton Bicentennial Committee desires to plan and construct a swimming pool, and

WHEREAS, neither organization is eligible for government grants, government loans, and other auxiliary financing, and

WHEREAS, the Village Board of Trustees of the Village of Brighton is eligible to receive grants, loans and other auxiliary financing.

## NOW THEREFORE, BE IT RESOLVED:

- 1. That the Village Board of Trustees of the Village of Brighton shall undertake and obligate itself to sign a contract with architects for the designing and planning of a swimming pool.
- 2. That the Village of Brighton will make application for grants, loans and other auxiliary financing which may be available to communities for the planning, construction and operation

of swimming pools

- 3. That the Village of Brighton Board of Trustees will accept up to \$12,000.00 from the Brighton Bicentennial Committee and Brighton Picnic Association for the purpose of paying architects for designing and planning a swimming pool.
- 4. That in return for said funds, the Village of Brighton Board of Trustees will do everything necessary to assist the Brighton Bicentennial Committee in furthering the designing, planning, construction, and operation of said swimming pool.

A Hearing was held by the Zoning Board on Thursday, Dec. 30, 7 p.m. in the Brighton municipal bualding. Gary Miller, Zoning Chairman, called the meeting to order. Luella Cravens called roll of members.

Present: Miller, Sam Davis, Jay Sitzes, Harold Bott Absent: Ed Wittman, Vernon Rodney Also present were Luriel Bott, Atty. Watson, Luella Cra

Also present were Luriel Bott, Atty. Watson, Luella Cravens, Mr. & Mrs. Wesley George and Stan Eddington.

Gary explained the reasons for calling this hearing were:

1. Proposed change in Building Permit fee

2. Trailer in Georgine Acres.

He explained that the present fee was No Charge up to \$2000 and \$2.00 per M over \$2,000. The proposed changes are: 0-\$2,000, no charge - \$2,000 to \$5,000, \$5.00 and over \$5,000, \$40.00 and remove the requirements for submitting plans for residential property prior to securing a permit. Sitzes made motion that the above changes as proposed, be put into effect. Davis seconded. Roll call vote, carried unanimously.

Regarding trailer in Georgine Acres, Ron Baron, Zoning Inspector, has advised that Wesley George, 229 Virginia, has met all requirements, the neighbors have signed. The trailer is for their mother who is in ill health. Bott made motion to approve the application for a special use permit as requested by Mr. George. Sitzes seconded. Roll call vote, carried unanimously.

Sitzes made motion to adjourn to regular meeting. Davis seconded. Adjourned 7:30 p.m.

Adjournment to regular meeting: Stan Eddington was concerned about a possible trailer court which Glenn McElroy is planning on putting up west of town. He is not opposed to one trailer, but he nor four adjoining neighbors of McElroy approve of a He has spoken to a Jersey Co. board member and he said if it came under town jurisdiction, they would have precedent over the county. McElroy has been informed that he has to apply for permit and said he will do it. He is in violation of our zoning ordinance with the one trailer which has been in since November. Some of the reasons for objections to the trailer court are that there would be sanitary runoff on various property owners and they would have to have septic tanks. Atty. Watson suggested that Zoning Inspector send registered letter to McElroy advising him that he is in violation of law regarding certain sections of zoning ordinance and must take immediate steps to remedy the problem.

Davis made motion to adjourn. Bott seconded. Voice vote, carried unanimously. Adjourned 7:40 p.m.
