

Brighton, Illinois  
November 14, 1977

A special meeting of the Village Board of Brighton was called to order at 7 p.m., November 14, 1977, in the Brighton municipal building. Clerk called roll of trustees:

Present: Little, Carr, Birk, Markwardt, Wild  
Absent: Wooldridge

Clerk read the letter of resignation from Police Chief William Broyles. Don Little made a motion that letter of resignation from William G. Broyles be accepted. Ken Markwardt seconded motion. Roll call vote, passed unanimously.

Discussion was held concerning advertising for Police Chief and a Patrolman. Bob Birk made a motion that Clerk place ad in Jersey, Alton, Gillespie, Southwestern papers for a Chief of Police and a Patrolman with salary negotiable depending upon years of experience and education, applications to be in by November 28, 1977, to the Clerk. Harris Carr seconded motion. Roll call vote, passed unanimously.

Mr. Roland Longcor, of Morton Buildings, Inc., read the letter of correspondence from Charlie Sheppard concerning additional items to be covered by contractor before contract should be signed. Motion was made by Bob Birk to authorize Mayor Ahlemeyer to sign contract after Morton's engineer makes necessary adjustments including steel door instead of wooden door as called for, and we provide labor in unloading and pay 30% down, 30% upon delivery and balance upon completion for discount savings. Harris Carr seconded motion. Roll call vote, passed unanimously. Motion was made by Harris Carr to transfer \$9,000.00 from Sales Tax Fund to General Fund to cover 30% down payment on Storage Building. Don Little seconded motion. Voice vote, carried unanimously. Work to be completed in 45 working days stated Mr. Longcor. Clerk was instructed to contact Illinois Power to move night light by present building.

Bid to improve dog pound facilities was reviewed. Bid was from Paul Clark for \$625.53 for sides, roof and floor. Ken Markwardt made a motion that these improvements be made by bidder if it qualifies it for a license from the state by meeting requirements. Harris Carr seconded motion. Roll call vote, passed unanimously. Clerk is to call Department of Agriculture to have inspector meet with George Farmer and Paul Clark at pound before beginning work.

Don Little made a motion to adjourn. Ken Markwardt seconded motion. Voice vote passed unanimously.
