#### 7. Audience Comment:

Annette Pentecost on Cindy St. Informational meeting last august, while village repaired sewer last fall, it is in previous minutes that homeowners could replace laterals with a reduced rate. Why not told of special rate when problem Contractor had yards tore up? The Board had approved this, however Contractor did not. The problem began in April when sewer backups started with heavy rains. Her yard was not put back. Mayor Schafer suggested contact GL Warren for yard issue. Mayor Schafer said borrowed money thru IEPA loan, took 3 years to replace lines, except Mobile St which was done earlier. We are asking for homeowner to correct the over infiltration. We have to show cause to EPA we are asking for help. We are 99.9 per cent contained with extra filtration.

Annette: if City was aware there was a problem, why weren't the homeowners contacted then about special rate? If the Mayor suggested a special rate, it still has to be approved by board, once the Board approves, G.L. Warren must also approve, which they did not. Homeowners must take up with GL Warren. The city has contained their situation; City is asking if you can work on your personal situation. The system under the city side is contained. Audience asked for special meeting. Mayor opened meeting to entire audience if it takes till midnight.

Herman Ganz 225 Virginia was told it was good by contractor at beginning of job.

226 Cindy Dawn Morgan was also told her laterals were good by contractor at beginning of job.

Mayor says in certified letter it explains to come up and talk to Steve. Barry Stanley said camera from back then was just to check for clogs, not to check for water infiltration. Therefore, when sewer was replaced, City was not aware of infiltration. The new camera shows the infiltration. Everyone received a letter, can't isolate homeowners at this time. We are just asking you try to correct any problems, showing EPA we are making effort to correct problem. Is there ever a time that homeowner is going to be forced to correct by removing clay pipes? If major hardship and you know you can't handle in 90 days, talk to Steve Mount, EMC Manager. Contractor not totally released per Mayor, we hold 5 % of their money, but technically not done yet. We had to seal it to contain it. We could only camera for clogs, roots at that time,

Darren McKee, manhole covers were not sealed. Mayor says system is contained. We were blessed to get money, but we have limited funds. To get storm sewers repaired, it's general fund money, not part of this sewer project. No money available State or Federal for storm drain system.

Mayor: if we can contain and fix the surface water into the system, then the sewer is fixed. Why not rest of town? Worst area for sewer problems was Georgene Ares.

Another visitor has water that washes rock from culvert; per mayor this is surface water again. This is a separate issue. It is not sewer sanitation.

Mayor commented that we are trying to fix #1 problem the sewer problems in Georgene Acres and #2 is to protect the new plant. We are trying to fix problem, we have fixed it, we are now asking for homeowners

to fix problem. We have turned in 4 sewer backups to insurance company. We have tried to fix the problem. If it is a hardship, come talk to us. We'll try to work out a legitimate time frame.

Surface water and draining that off, no ordinance on that. Only ordinance on sanitary system. We are continuously trying to fix problem.

- Oertel made motion to have Valerie Lucas to work a few hours in clerk's office. Roberts, 2<sup>nd</sup>. Roll Call, all Ayes, no Nays. Motion carried.
- IL Municipal Retirement Fund Training for Village Clerk Aug. 15, no fee's associated other than mileage
- Discuss removing pay phone outside doors and replace with locked display case. Cost \$200-\$300. Per OMA, all agenda's must be viewable 24/7 by public.
