Action Items e. City Limits Road- in past heavy grading due to traffic had deteriorated this road where repairs are needed. The road also needs to be opened up for drainage. Public Works recommends repaving and putting a skirt from highway headed East to open up the ditches and then do first 75' apron feet from highway going east, concrete this, by doing it correctly with coring it out, packing down 8" rock, then repaving. Currently traffic is so heavy, the ditches have been rolled flat. This would be priority. The ditches have wallowed out and needs the base shored up. The heavy traffic keeps pushing the road into the ditches. Cannot use MFT. Steve Mount doesn't think it will cost \$40,000, however, the unforeseen, he recommends it needs to be done as soon as possible. This portion does fall in BDA. Oertel made a motion to resurface E. City limits road in regards to committee recommendations, 2nd by Jacoby. Roll Call, Chris Dawdy-Y, Bill Oertel-Y, Fred Benz-Y, Ed Jacoby-Y, Mike Roberts-Y, Jamie Boyd-Y. Motion Carried.

Action Items g. Lateral Repairs – Belvedere Subdivision. Odesco did camera the Belvedere Subdivision, lots of homes below sewer, lots of tree roots. Odesco suggest using chemical grout to go up the lateral and grout up to 3 feet. They go up and inject this chemical grout which will fill any cracks. Costs \$45,900 if every sewer in Belvedere, 1900 feet from Highway all away around. Visitor Dave Kitzmiller/Amwater mentioned that Odesco is not the only company that does this chemical grouting. There is a company in St. Louis that does this also. It is more of a silicone. This company puts a root inhibitor in the grout that prohibits root growth. Dawdy made a motion to get bids on joint grouting for tapping lateral repair in Belvedere, 2nd by Oertel. - 13) Hiring of Bank Attorney: Attorney Watson explained that public financing is 10 years or less for W. Center St. Bids are due back on April 14, 3:00 PM. Financing for W. Center St is about \$900,000. Everything for this funding is very strict. A St. Louis attorney quoted \$15,000 to write legal and set parameters. Attorney Watson thought this was high, so he contacted Rural Development, they recommended Kurt Froehlich from Springfield, IL His quoted price was \$2,750. Since this has to meet many IRS and technical rules, Attorney Watson would like to recommend hiring Kurt Froehlich to do this financing project for W. Center St. It has to meet 501C3. Meaning, they won't have to pay income tax on the earnings. This should make them much more competitive in the bidding. Jacoby made motion to retain Attorney Kurt Froehlich, 2nd by Benz. No charge to residents for electronic recycling. Dawdy suggests doing same day as Yard Sale.
