MINUTES of a adjourned regular public meeting of the President and Board of Trustees of the Village of Brighton, Macoupin and Jersey Counties, Illinois.

The President and Board of Trustees of the Village of Brighton convened in adjourned regular public session this 3rd day of August, 1960, at 8:00 o'clock P.M. at the Village Hall, with the President, Eugene Bott, in the chair and presiding, and James F. Hughes, Village Clerk, attending.

The President directed the Village Clerk to call the roll, and upon roll call the following Trustees answered present: Marvin Powell, Emery Kamp, Calvin Vonnahmen, Raymond Schoeberle. and the following Trustees were absent: Harold Dodge, Fred Scheffel.

ORDINANCE #255

Trustee Vonnahmen then did present to the Village Clerk an ordinance entitled,

"AN ORDINANCE calling a special election to vote \$65,000 Sewer Bonds of the Village of Brighton, Macoupin and Jersey Counties, Illinois."

The Village Clerk did thereupon read said ordinance to the Board in full, and after full discussion was had thereon Trustee Powell made a motion that said ordinance as read be adopted, which motion was seconded by Trustee Kamp, and upon roll being called the following Trustees voted Aye: Powell, Kamp, Vonnahmen, Schoeberle and the following Trustees voted Nay: None.
