ORDINANCE #259.

AN ORDINANCE REPEALING ORDINANCE # 240 AND PRESCRIBING RULES AND REGULATIONS FOR CONNECTIONS WITH THE BRIGHTON MUNICIPAL WATER SYSTEM.

A letter from the Civic League, regarding taverns closing on certain election days was read before the village board.

Powell moved and Vonnahmen seconded the motion to authorize the village engineer to draw up plans and prepare bid proposals for replacing some 2,500 feet of water line on North Humbert Road from Fosterberg Road to Bethany Lane.

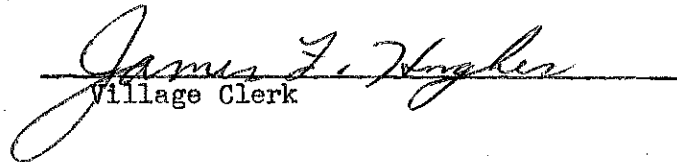

#262 "AN ORDINANCE AUTHORIZING \$444,000 WATERWORKS AND SEWERAGE REVENUE BONDS, SERIES OF 1961, OF THE VILLAGE OF BRIGHTON, MACOUPIN AND JERSEY COUNTIES, ILLINOIS, AND PROVIDING FOR THE PAYMENT, SALE AND DELIVERY, THEREOF, AND MAKING CERTAIN COVENANTS IN THAT CONNECTION."

The village clerk did thereupon read said ordinance to the board in full, and after full discussion was had thereon trustee, Kamp, made a motion that said ordinances as read be adopted, which motion was seconded by trustee, Vonnahmen and upon roll call, the following trustees voted Yea: Kamp, Powell, Vonnahmen, Schoeberle, Lucker, and the following trustee voted Nay: None.

Thereupon the president did declare the motion carried and the ordinances adopted, and did thereupon sign and approve the same in open meeting and direct the village clerk to file said ordinances in the official ordinance book of said village, and to file a true copy thereof in the minutes of this meeting, which was done.

Being no further business to come before the board, Schoeberle moved and Powell seconded the motion to adjourn. Motion carried. Meeting adjourned.
