Motion by Trustee C. Vonnahmen to call for bids on the moving of pipe line from Fosterburg Road to Mason Corner on North Humbert Road, bids to be received till 8:00 P.M. D.S.T. Monday, May 14, 1962, when they will be opened, seconded by M. Anders.

Voice Vote Carried, no dissent

President Bott reported on Workshop he attended at Benld that it could be possible that some funds might be available for financial help on water line change and tank and standpipe.

Trustee St. Cin made motion to pass Resolution asking for permit to lay sewer along, under, and across Highway 111 & 67 from the State Dept. of Public Works & Buildings, seconded by E. Kamp.

Voice Vote Carried, no dissent.

Trustee E. Kamp made the motion to procure the \$4,000.00 Bond for the Village that the Highway Dept. requires, seconded by F. G. Scheffel.

Voice Vote Carried, no dissent.

Trustee Geo. St. Cin made motion that President and Clerk sign request for permit and send all to Dept. of Works & Buildings, seconded by C. Vonnahmen.

Carried, no dissent.

Engineer C. Abraham received two bids on cleaning, sandblasting and painting of water tank which were then discussed.

Also present at the meeting were a Citizens Advisory Committee appointed by H. G. Bott to collaborate with the Town Board on sewer project, namely Gene St. Cin, Carl Collins, Leo Bergfeld, Harold Heideman, George Tuey, V. W. Schroeder.

Engineer C. Abraham and Mr. D. McGowin then discussed problems concerning sewer. Abraham discussed flow of sewerage from plans, placement of lift stations, size of tile, etc. Section of town east of Burlington RR. was discussed and Abraham estimated cost might run \$18,000 to \$25,000. Figure for total sewer job was outlined as \$340,000 and now several new subdivisions have been added. Mr. McGowin said an alternate bid might be requested for area east of Burlington R.R.

H. C. Chase gave the number of signers for sewer as 177, also stated that water patrons in village were now 375.

The town was divided into sections by streets and were assigned to board members and some to advisory committee members to see that all homes were canvassed in regard to sewer sign up.
