AN CRDINANCE making a levy of taxes for corporate purposes for the fiscal year ending the first day of May A. D. 1937.

D. 1936, an annual Appropriation Ordinance Number 140, which said Ordinance was duly signed and approved on the fifth day of May A. This Ordinance shall be known as OrdinanceNumber 141 and shall be in force from and after its passage and approval.
