ORDINANCE NUMBER 143.

AN ORDINANCE MAKING APPROPRIATION FOR CORPORATE PURPOSES FOR THE FISCAL YEAR FROM THE FIRST DAY OF MAY A.D. 1937 to the FIRST DAY OF MAY A. D. 1938

It is ordained by the President and Board of Trustees of the Village of Brighton, in the Counties of Macoupin and Jersey, in the State of Illinois.

SECTION NUMBER ONE:

That the following sums or so much thereof as may be authorized by law, be and the same are hereby appropriated for corporate purposes of the Village of Brighton, as hereinafter specified, for the said fiscal year beginning May first A. D. 1937:
