Section Four. Any person, firm. corporation or servant or employees thereof, who shall neglect, fail or refuse to comply. with the provisions of this ordinance shall be fined not less than Five (\$5.00) Dollars, nor more than Two Hundred (\$200.00) Dollars for each and every Offense.

Section Five All Ordinances or parts of ordinances, and all resolutions conflicting herewith be and the same are hereby repealed.

This Ordinance shall be in full force and effect Section Six. from and after ten days from the time the same is passed, signed and published as required by law.

D. 1938, and shall mature and be paid in the sum of Five Hundred (\$500.00) dollars each year; beginning in 1942, until the whole of said series shall be paid annually at the Office of the Village Treasurer in the Village of Brighton at the rate of Three per cent (3%) per annum.

Section Five (5): Ordinance number 146 is hereby repealed.
