September 6, 1938

The Village Board met in regular session on Tuesday evening in the Village Hall.

The following Officers were present: Pres. O. C. Isenberg, Treas. Wm. Schneeberg, Clerk H. G. Bott, Trustees Lucker, Schoeberle, Schmidt, Scheffel.

Treas. Wm. Schneeberg made Treasurer's report as follows:

It was properly moved by Trustees Scheffel seconded by Lucker that the Treas. report be accepted as read.

The Motion carried by roll call as follows: Schoeberle Yes; Schmidt Yes; Scheffel Yes; Lucker Yes.

The Village Hall report was read to the Village Board. It was properly moved by Trustees Schoeberle seconded by Lucker that the Hall report be accepted as read. Carried.

President of the Village Board instructed the Village Clerk to notify Paul Brands in writing that unless the Hall rent due the Village of Brighton is paid on or before 6 P.M. Sept. 10, 1938 he will be refused the use of the Hall, after that time settlement in full must be made monthly.

It was properly moved by Trustees Lucker, seconded by Schmidt that the Village Board confirm the instructions of the President.

Further action was delayed on account of General Fire Truck Co. agent.

The vote on the motion was a tie: Schoeberle No; Schmidt Yes; Scheffel Yes; Lucker Yes. The President of the Village Board decided the tie by voting Yes on the motion.

It was properly moved by Trustees Scheffel seconded by Schmidt that the Village Board pay the \$300... note and interest due First National Bank of Brighton and also the interest on \$500.00 note due First National Bank of Brighton.

The motion carried by roll call as follows: Schoeberle Yes; Schmidt Yes; Lucker Yes; Scheffel Yes.

It was properly moved by Trustees Scheffel seconded by Lucker that the meeting adjourn. Carried.
