## ORDINANCE NUMBER 152.

An Ordinance making a levy of Taxes for Corporate Purposes for the Fiscal Year ending the First Day of May A. D. 1940.

WHEREAS, There was duly passed at a regular meeting of the Village Board of Brighton, held on the second day of May A. D. 1939, an annual appropriation Ordinance Number 151, which said Ordinance was duly signed and approved on the second day of May A. D. 1939 by the President and the Village Board of said Village, and published in the Brighton News a weekly secular newspaper of general circulation, published in said Village, making appropriation for corporate purposes, as follows, to-wit:-

D. 1940, the sum of Four Thousand Three Hundred (\$4,300..0) Dollars that the several accounts levied and to be collected for each purpose are as follows:

The Village Clerk of the Village of Brighton is hereby directed to make and file with the County Clerk of Macoupin County, and also with the County Clerk of Jersey County, immediately upon the passing of this Ordinance, a certified copy of this Ordinance, under the corporate seal of the Village of Brighton, Illinois, for the purpose of causing this levy to be extended on the tax books, as it is now required by law.

This Ordinance shall be known as Ordinance Number 152 and shall be in force from and after its passage and approval.
