ORDINANCE NUMBER 154.

An Ordinance Regulating the Storage, Sale and Use of Fire Works.

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLACE OF BRIGHTON IN THE COUNTIES OF MACOUPIN AND JERSEY, IN THE STATE OF ILLINOIS:

SECTION ONE: It shall be unlawful to store any fireworks in the Village of Brighton, Illinois, excepting as may be necessary for the giving of a licensed public exhibition of pyrotechnics as it provided for in this ordinance.

The discharge, firing, or use of all firecrackers, rockets, torpedoes, roman candles, or other fireworks or substances designed and intended for pyrotechnic display and of all pistols, canes, cannons, or other appliances using blank cartridges or caps containing chlorate or potash mixture, is hereby prohibited. Provided that the President may order the public display of fireworks by properly qualified individuals under the direct supervision of experts in the handling of fireworks. Provided also that such display or displays shall be of such a character and so located as in the opinioncof the President and the Board of Trustess shall not be hazardous to surrounding property, or endanger any person or persons.

SECTION TO: The sale of any fireworks or pyrotechnics at retail is prohibited within the limits of the Village of Brighton, Ill.

SECTION THREE: Any person, firm, or corporation violating any of the provisions of this ordinance shall be deemed guilty of a mis demeanor and be fined not less than ten (\$10.00) Dollars nor more than One Hundred (\$200.00) Dollars for each neglect of compliance.

SECTION FOUR: That all ordinances and parts or ordinances and all resolutions and parts of resolutions conflicting with this ordinance be and the same are hereby repealed.

SECTION FIVE: That should any portion or portions of this ordinance for any reason be declared invalid or unconstitutional by any court of competent jurisdiction passing upon the same, that it is the intention of the Board of Trustees herein expressed that such invalidity of any portion or portions of said ordinance shall not in any way effect the validity of the remainder of said ordinance not thus declared invalid or unconstitutional.

SECTION SIX: This ordinance shall be in full force from and after its passage and approval.
