ORDINANCE NUMBER 163

Ah Ordinance making a lety of Taxes for Corporate Purposes for the Piscal Year ending the first day of May A. D. 1943.

Whereas, there was duly passed at a regular meeting of the Board of Trustees, of the Village of Brighton, held on the second day of June A. D. 1942, an annual Appropriation Ordinance Number 162 by the President and the Board of Trustees of said Village, and published in the Brighton News, a weekly secular newspaper of general publication, published in said Village, making appropriation for corporate purposes. as follows: To-wit:

For Electric lights on streets -----\$ 1000.00 For officers salaries -----300.00 For salary of village marshall -----840.00 For streets, alleys and widewalks -----2000.001 For expxnses of village board of health -----50.00 For election expenses 100.00 For printing and supplies ------50.00 For fire protection purposes (under special act) --600.00 Total ---- \$ 4940.00

Therefore: Be it ordained by the President and Board of Trustees of the Village of Brighton, Counties of Macoupin and Jersey, State of Illinois, that there shall be assessed, levied and collected upon all real estate and personal property within the corporate limits of said Village of Brighton, Illinois, as the same appears from the regular assessed value thereof, to meet the appropriation for the corporate purposes heretofore mentioned, for the fiscal year ending on the first day of May A. D. 1943, the sum of Four Thousand Nine Hundred Forty Dollars (\$4940.00) that the several accounts levied and to be collected for each purpose are as follows:

For electric lights on streets ----- \$ 1000.00 For officers salaries 200.00 For salary of village marshall -----840.00 For streets, alleys and sidewalks -----2000.00 For expenses of Village Board of Health -----50.00 For election expenses -----100.00 For printing and supplies -----50.00 For fire protection purposes (under special act) -600.00 Total ----- \$ 4940.00

Any unexpended balances remaining out of any of the aforementioned items may be paid out and expended in making up any deficit existing in any other item or items.

The Village Clerk of the Village of Brighton is hereby directed to make and file with the County Clerk of Macoupin County, and also with the County Clerk of Jersey County, immediately upon the passing of this Ordinance, under the Corporate Seal of the Village of Brighton, Illinois, for the purpose of causing this levy to be extended on the tax books, as it is now required by law.

This ordinance shall be known as Ordinance Number 163 and shall be in force from and after its passage and approval.
