The Clerk read a new Ordinance entitled: "AN ORDINANCE PROVIDING FOR THE HOLDING OF A SPECIAL ELECTION AT WHICH TO SUBMIT TO THE VOTERS OF THE VILIAGE OF BRIGHTON, MACOUPIN AND JERSEY COUNTIES, ILLINOIS, A PROPOSITION AUTHORIZING THE LEVY OF A RATE FOR GENERAL CORPORATE PURPOSES OF NOT TO EXCEED 87½ HUMDREDTHS OF 1% PER ANNUM FOR EACH OF THE YEARS 1945, 1946, 1947, 1948 and 1949 AND APPOINTING JUDGES AND CLERKS TO CONDUCT BAID SPECIAL ELECTION."

It is moved by Trustee Gaither and seconded by Trustee Scheffel that all rules of the Village Board of the Village of Brighton which might prevent, unless suspended, the final passage and adoption of said proposed ordinance at this meeting be and the same are hereby suspended for the purpose of permitting the final passage and adoption of said ordinance at this meeting.

The roll being called upon the question of the adoption of the motion to suspend such rules, the following vote was recorded:

Being no unfinished or new business to be cared for when called for by the Mayor the motion was made by Trustee Ziegenbein and seconded by Trustee Kuehnel to adjourn. Motion carried.
