ANNUAL LEVY ORDINANCE

AN ORDINANCE LEVYING TAXES FOR ALL CORPORATE PURPOSES FOR THE VILLAGE OF BRIGHTON, MACOUPIN AND JERSEY COUNTIES, ILLINOIS FOR THE FISCAL YEAR COMMENCING ON THE 1ST DAY OF JULY 2024, AND ENDING ON THE 30TH DAY OF JUNE, 2025.

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BRIGHTON, MACOUPIN AND JERSEY COUNTIES, ILLINOIS, as follows:

SECTION 1. That the sum of Three Hundred and Fifty-Four Thousand Three Hundred and Seventy-Five Dollars (\$354,375.00), being the total amount to be levied of the budgeted appropriations having been heretofore made for the corporate and municipal purposes of the Village of Brighton, Macoupin and Jersey Counties, Illinois, for the fiscal year commencing on the 1st day of July, 2024 and ending on the 30th day of June, 2025, as approved by the Board of Trustees of the Village of Brighton, be and the same are hereby levied on all property subject to taxation within the corporate limits of the Village of Brighton, Macoupin and Jersey Counties, according to the valuation of said property as is, or as shall be assessed or equalized for State and County for purposes for the current calendar year, 2024, and for such purposes as: General Corporate, Streets, ESDA, Parks, Insurance, Social Security, Police, Illinois Municipal Retirement Fund, and Auditor. The budgetary appropriations heretofore having been made by the Board of Trustees of the Village of Brighton, Macoupin and Jersey Counties, Illinois.

SECTION 2. That the amount levied for each object and purpose is placed in a separate column as hereinafter stated.

SECTION 3. It is intended for the Village of Brighton to levy total real estate taxes equal to the maximum allowed by law.

SECTION 4. That the Village Clerk of the Village of Brighton is hereby directed to certify two copies of this Ordinance and is further authorized and directed to file a copy of the same with the County Clerk of Macoupin County, Illinois, and with the County Clerk of Jersey County, Illinois, on or before the last Tuesday in December.

SECTION 5. That if any part, section, subdivision, or sentence of this Ordinance shall, for any reason, be held invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of this Ordinance. The Board of Trustees of the Village of Brighton hereby declares that it would not have passed such parts of this Ordinance if it had known that

said part, section, subdivision, or sentence would be declared unconstitutional or otherwise invalid.

SECTION 6. That this Ordinance shall be in full force and effect after its adoption as provided by law.
