ORDINANCE NO. 2025-09

AN ORDINANCE AMENDING THE MUNICIPAL CODE OF THE VILLAGE OF BRIGHTON MACOUPIN AND JERSEY COUNTIES, ILLINOIS

CHAPTER 30 SECTION 07 STANDING COMMITTEES

WHEREAS, on July 1, 2024, the President and Board of Trustees of the Village of Brighton adopted a new Code of Ordinance Book; and

WHEREAS, the President and Board of Trustees of the Village of Brighton have determined that the most efficient way to regulate the governing body of the Village of Brighton is through the use of standing committees; and

WHEREAS, the President and Board of Trustees of the Village of Brighton have determined it is necessary to restructure the standing committees in order to allow more efficient use of governmental time, funding and service.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF BRIGHTON, MACOUPIN AND JERSEY COUNTIES, ILLINOIS, as follows:

- Chapter 30, Section 7, Paragraph 1-5 is hereby stricken in its entirety, and is replaced with the following:
 - A. COMMITTEES ESTABLISHED: The following standing committees are hereby established:
 - Public Works Committee: The Public Works Committee will consist of a minimum of two (2) Trustees, one of which will serve as chairperson, and a minimum of three (3) non-trustee members may be appointed at the discretion of the Village President, with approval of the Village Board of Trustees. The Public Works Committee will serve as an advisory body to the Village Board of Trustees in matters related to:
 - a. The operation of the Public Works Department;

- Maintenance of current municipal structures and facilities with the planning of any future building needs;
- c. Policy regarding access to municipal buildings and facilities;
- 2. Public Safety Committee: The Public Safety Committee will consist of a minimum of two (2) Trustees, one of which will serve as chairperson, and a minimum of three (3) non-trustee members may be appointed at the discretion of the Village President, with approval of the Village Board of Trustees. The Public Safety Committee will serve as an advisory body to the Village Board of Trustees in matters related to:
 - a. The operation of the police department;
 - b. The regulation of vehicular traffic on Village streets;
 - c. The placement of lighting within the Village;
 - d. The operation of the animal control department;
 - e. The emergency services and disaster agency; and
 - f. The President of the Village shall appoint a member of this committee to serve as a liaison to other public safety, emergency, and/or disaster agencies, and provide recommendations to the Village Board of Trustees, as needed.
- 3. Park and Recreation Committee: The Park and Recreation Committee will consist of a minimum of two (2) Trustees, one of which will serve as chairperson, and a minimum of six (6) non-trustee members may be appointed at the discretion of the Village President, with approval of the Village Board of Trustees. The Park and Recreation Committee will serve as an advisory body to the Village Board of Trustees on matters related to the development and use of Village parks and promotion of recreational activities and events.
- 4. <u>Community Development Committee</u>: The Community Development Committee will consist of a minimum of two (2) Trustees, one of which will serve as chairperson, and a minimum of five (5) non-trustee members. Members shall be appointed by the President of the Village Board and confirmed with the advice and consent of the Village Board of Trustees. The Community Development Committee will serve as an advisory body

to the Village Board of Trustees on matters related to the planning and economic development of the Village.

- a. The Community Development Committee shall meet on the second Tuesday of every month.
- II. That this Ordinance shall be in full force and effect from and after its passage and approval by the President and Board of Trustees of the Village of Brighton.
